# Strategic Objectives and Priorities: Defined and taken over from the faculty strategic Plan

# The category-wise departmental Strategic Objectives of the Information Technology Department are given here:

# 01: Students Professional Excellence: To recruit, retain and graduate a larger, academically prepared, and diverse student community

Over the next five (05) years, the Department of Information Technology will emphasize student enrolment by providing academic services aligned with society's needs. Utilizing modern trends in technology will increase students' technical and professional skills. For this purpose, students will be facilitated in terms of financial assistance, knowledge dissemination, and extra training in Information Technology.

Learning Management System plays a vital role in facilitating students academically. Therefore, teachers will be motivated to upload all relevant academic material on time to the LMS, and students will be advised to regularly check their online accounts for study material, quizzes and assignments. Students would be strictly discouraged from sending assignments to the teachers via email. Only those assignments will be graded which uploaded from the student's online account.

To achieve this strategic objective, the following strategic priorities will be followed.

# 02: Faculty Excellence: Attracting and Retention of highly qualified faculty members

Technology.

High-qualified and well-experienced faculty members play the backbone in the development and performance of any academic department. Therefore, the Department of Information Technology will try hard to hire qualified and experienced faculty members over the next five years. For this purpose, close coordination will be established with the human resource department to facilitate the scrutiny and hiring. The Department should fill faculty need assessment form before the HR office makes any announcement for new hiring by mentioning the required qualifications and experience.

Similarly, to retain the existing faculty members and improve their teaching and research skill, different type of training will be organized, and annual increments will be given to faculty members based on their performance to create a culture of competition. Based on their interest and willingness, each faculty member will be allocated to different departmental committees based on their interest and experience rotationally.

The following strategic priorities will be considered for achieving this strategic objective.

Priority No. 01 To induct experienced and qualified faculty members with an emphasis on female faculty members.

### 03: Research Excellence: The flagship objectives critical to the success of the Information Technology department

The main reason for academic institutions is to provide a solution for real-world problems by conducting research using scientific methods. Faculty members and students need to be involved in research activities in Information Technology. By close coordination with the FDC, the Department of Information Technology will remain engaged to enhance the research capacity of teachers and students and organize research seminars, workshops, and training required for conducting research.

Research culture will prevail by motivating each faculty member to publish research articles in the Kardan Journal of Engineering and Technology (KJET) semester and annually. For this purpose, a conducive research environment will be provided by utilizing the digital library, well-furnished faculty room, and financial support for paper publishing and attending research conferences.

In this connection, the following strategic priorities need to be considered for achieving this objective.

- Priority No. 01 To provide a conducive research environment
- Priority No. 02 To organize symposiums and research competitions
- Priority No. 03 Modernize and strengthen undergraduate programs by Influencing research culture

# 04: Excellence in Digitalization and Innovation with a focus on brand identity: Excellent resources and infrastructure to maximize the use of technology in the delivery of services

Along with academic excellence, the Department of Information Technology is known for its best and timeliest services provided to students and other stakeholders over the past years. In this connection, it is required to modernize the existing computer labs with all the necessary software installed on each system. Eight (08) computer labs were established in the Department of Information Technology along with CISCO and Innovation Lab. Over the next five years, these labs will increase to ten (10).

Furthermore, the Department of Information Technology will actively support students academically online.

In essence Department of Information Technology shares a common value with the University in creating the digital world inside the department. Everything is digitized, from Computer Labs to classroom attendance, from office to notice board, and from examination to result in the declaration.

### 06: Partnership for the MoHE Strategic Goals:


