# **STRATEGIC PLANNING PROCESS**

The Faculty of Law's five-year strategic plan was developed using a standard planning process framework. The planning process began by gathering data from internal and external stakeholders, including employers, students, alumni, faculty members, and academic staff. We assess our strengths and weaknesses, opportunities, and threats; during the Focus Group Discussion, the challenges are addressed in the university's present, future, and internal and external environment.

The participants' statements were collected in open Code and categorized into grouping themes (Axial Codes) and final themes (selective Code). The final themes were used to set the strategic goals of the Faculty of Law. The drafted strategic goals and Vision, and Mission were discussed in the faculty workshop and presented in the PTF (Planning Task Force) committee of the University.

Finally, the strategic goals of the faculty are prepared based on the findings from FGDs and aligned with the University's strategic goals.

For the next five years we will offer financial assistant for eligible students in order to enable them for pursuing their higher education, furthermore we will take part in any social activities like conducting of conference, seminars, workshops for the public and private sectors on law related issues.
